Module Description:

This course gives a general introduction to inheritance and what is related to it in rights, while focusing on wills, their conditions, pillars and the bases of applying mandatory testaments, and the existence of more than one testament and their invalidity. This course clearly addresses inheritance in Islamic Law insofar as its necessity, pillars and conditions, and a comparison between it and old and modern inheritance systems, in addition to designating the inheritors from among men and women through statutory portion or group or kinship and other inheritance themes such as sustenance ('awl), restitution (rad), disassociation (takharuj), the inheritance of un unborn child, the missing, victim of destruction (hidmi), the drowned and traffic accidents victims.

Module Aims: This module aims to:

- 1. provide students with the basic as well as advanced knowledge in Islamic inheritance and wills, in addition to its role in settling disputes between relatives
- 2. develop students cognitive as well as practical skills in inheritance and will related topics, in addition to develop their capacity to learn and apply theoretical knowledge to obligations accounts and its terms and conditions to actual and/or presumed cases
- **3.** develop students skills in writing and preparing article, reports and research papers in compliance with an intact research scheme
- 4. prepare and qualify students to receive legal technical training to work in legal fields relevant to inheritance regulations and in compliance with the demand of the job market
