Terms and Criteria for Submitting Research Papers:

- 1. The research paper must address one of the conference themes.
- 2. All research papers will undergo scientific review by the appropriate scientific committee.
- 3. Submissions are accepted in both Arabic and English.
- 4. The first page of the research must include the conference name, the organizing body, the full title of the research (in both Arabic and English), the researcher's full name, academic degree, workplace, and email address.
- 5. The scientific research methodology must be adhered to when writing the paper, and the research must be original and contemporary.
- 6. The research must not have been previously published, accepted, submitted for publication, or presented at any other conference.
- 7. The research must not exceed 20 pages or 10,000 words, including references and appendices as follows:
 - ✓ The research paper must be written using Microsoft Word.
 - ✓ Font type (Time New Roman) for texts in both Arabic and English.
 - ✓ Research title font 14 bold
 - ✓ Subheadings 12 bold
 - ✓ Research text font 12
 - ✓ Line spacing 1.5.
 - ✓ Researcher's personal information
 - ✓ Research summary in Arabic and English
 - ✓ Introduction
 - Research problems, significance, and objectives.
 - ✓ Method and procedures (methodology)
 - ✓ Results and discussion
 - ✓ Conclusions and recommendations
 - ✓ Citation of references according to the (APA) style, seventh edition.
- 8. All research papers will undergo plagiarism testing and evaluate the use of artificial intelligence, with a maximum acceptable percentage of 25%.

Publishing Opportunities:

The conference provides the following publishing options:

- 1. Publishing the accepted research paper in English in a book indexed within the Scopus database issued by Springer International Publishing House, noting that the publishing fees is (300) US dollars per research paper.
- 2. Publishing **the summary of the research paper** presented at the conference in the conference proceedings book electronically (PDF) for free, noting that this publication is the right of the conference organizer.
- 3. The conference participation fees do not include the fees for publishing the research paper in the book indexed within the Scopus database.
- 4. The researcher has the right not to publish the entire research paper in any of the above options.

Participation Fees:

- 1. Participation with a research paper: (\$75) or its equivalent in other currencies for each participant, including presentation of the research paper in the conference sessions, publication of the research paper in the conference proceedings book, breaks during the conference days, tourist trips and lunch over two days, conference badge, certificate of participation.
- 2. Attendance without participating with a research paper: (\$60) or its equivalent in other currencies, including breaks during the conference days, tourist trips, lunch over two days, and certificate of participation.
- 3. Travel, procedures, and accommodation costs are at the participant's expense.
